Your puppy must be taken to your vet within the first 72 hours of arrival for a Well Puppy Check-up. This is to verify the condition of the puppy when it arrives. Failure to do so will make this contract null and void. If, in the opinion of your veterinarian, your puppy has any health defect that makes it a poor health risk, you must notify the breeder within 7 days from the date of purchase. In the event that puppy is to be returned, the return should occur within ten days, including all papers, as well as a signed statement from the vet on the vet's letterhead, stating the date of examination and the alleged health risks. A puppy that is returned for health reason shall be replaced by another puppy as soon as a replacement puppy is available.

Puppies have had their initial vaccinations, but will require additional vaccines every 3-4 weeks until they have received all required shots. Your vet will offer recommendations and guidance in this regard. Puppies have also been dewormed regularly since they were 6 weeks old and this pup, by way of fecal exam, has been determined to show no signs of

worms. This puppy is guaranteed to be free of all communicable diseases for a period of ten days from the date of sale. Because puppies are not fully protected until they have received all of their immunizations, we cannot guarantee against Parvo after the initial 72 hours of arrival. Nor can we guarantee against the parasitic illnesses of Corona, Coccidiosis or Giardia, since these parasites can be picked up almost anywhere and vaccinations will not protect your puppy from them.

Your puppy is guaranteed for a period one year against genetic defects that would make the puppy non-suitable as a “family pet”. This one-year guarantee also includes PRA (progressive retinal atrophy). If a major genetic defect is found, puppy shall be returned to Kingsfield and we will exchange your puppy with another of equal value. We will need your veterinarian’s dated and signed statement of the puppy’s genetic condition and the cause of that defect or condition. The return transportation is at the buyer’s expense and the replacement puppy will be sent at the breeder’s expense. In the event of such return and replacement, this puppy must not have been bred or altered. At no time is seller responsible for any vet expenses including routine exams, illnesses, defects, or conditions caused by buyer’s neglect, abuse, improper nutrition, mishandling or any injuries to puppy caused by said conditions.

Guarantee of the actual mature weight of a puppy is impossible. We can estimate it based on the current weight of the puppy and its parents’ weights, but other factors such as genetics, overall health, exercise and diet also affect mature weight.

Breeder will provide all Registration papers when full payment is received from the Buyer, or as soon as possible after they have been provided by the registry. If Buyer fails to submit registrations papers to the appropriate registry to transfer ownership and gain permanent registration, this guarantee shall be considered null and void.
